# 3 YEARS OF GIVING BACK TO THE SOCIETY

## INTRODUCTION

**G**orporate Social Responsibility (CSR) is a voluntary commitment of a company or an organization to the immediate community it finds itself. It is an effort of such organization to improve society in some ways. Many organizations engage in CSR to improve the quality of life of the people, enhance its public image, increase media coverage, and to gain the trust or acceptability from the community. CSRs do not have to be a luxurious project, but it must address the basic need of the host community.

In Nigeria, due to paucity of resources, many communities are incapable of providing adequate basic social amenities for their immediate environment. These communities rely on government to provide basic facilities which are enormous for government to execute at the same time. Therefore, the dependence on government to provide all the needs of communities is becoming unrealistic considering the low federal allocation and Internally Generated Revenue (IGR) of many governments. This is where organizations come to play significant roles to compliment the efforts of the communities and the government in areas of needs. Corporate Social Responsibility (CSR) therefore allows organizations to contribute their quota for the society.

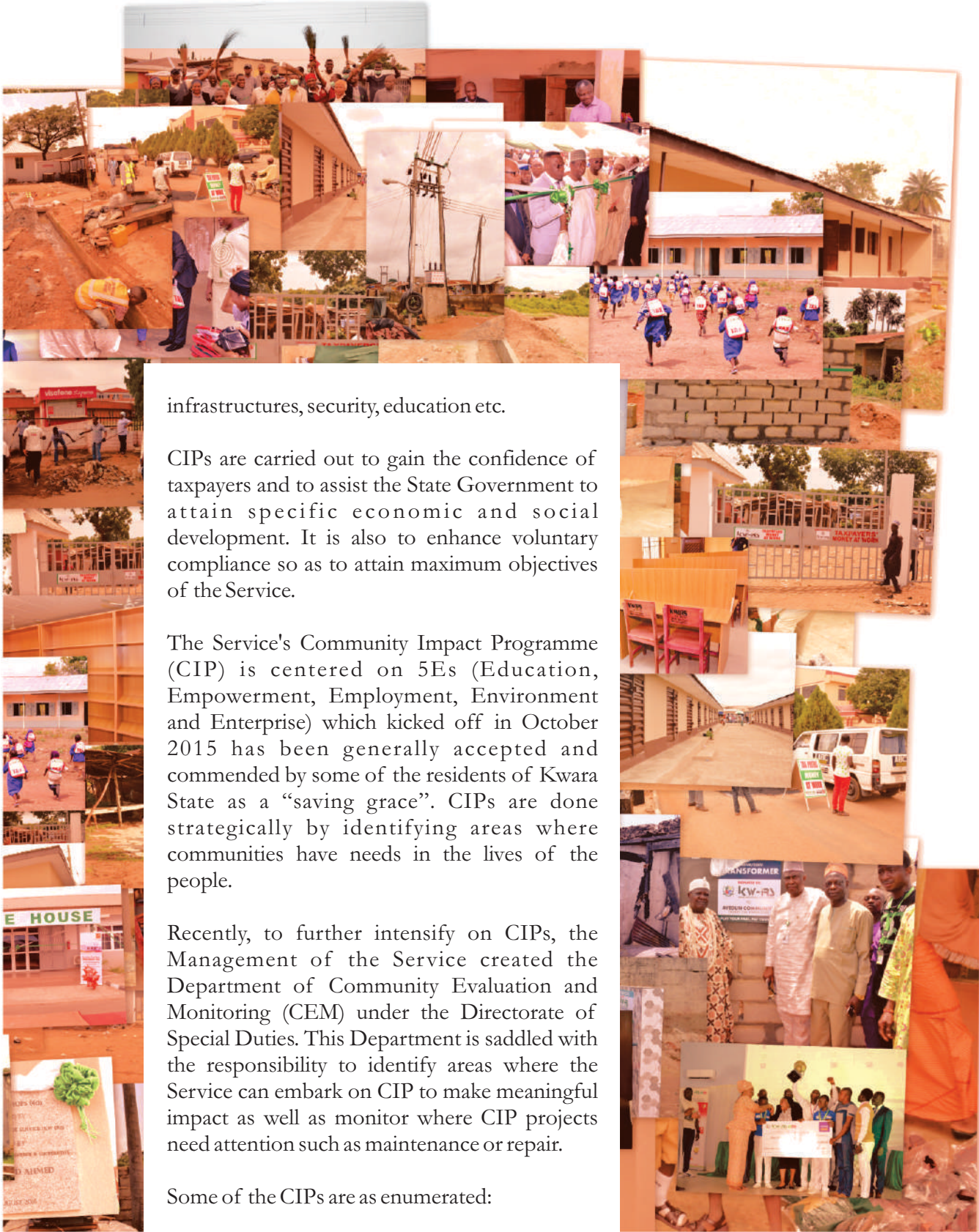

## COMMUNITY IMPACT PROGRAMMES AS STRATEGY

The establishment of Kwara State Internal Revenue Service (KW-IRS) by the Kwara State Revenue Administration Law 2015 (as amended) as the sole entity to collect all revenues in the State made a provision for the Service to embark on Corporate Social Responsibility (CSR) called Community Impact Programme (CIP). The Kwara State Government established KW-IRS to increase Internally Generated Revenue (IGR) which is being achieved so far without introducing new taxes but to increase the revenue base by blocking leakages.

Contrary to taxpayers' perception about tax bringing a direct dividend, tax is a compulsory fee levied on individuals or corporations without expecting direct benefits. Such money is used by the government to provide basic



infrastructures, security, education etc.

CIPs are carried out to gain the confidence of taxpayers and to assist the State Government to attain specific economic and social development. It is also to enhance voluntary compliance so as to attain maximum objectives of the Service.

The Service's Community Impact Programme (CIP) is centered on 5Es (Education, Empowerment, Employment, Environment and Enterprise) which kicked off in October 2015 has been generally accepted and commended by some of the residents of Kwara State as a “saving grace”. CIPs are done strategically by identifying areas where communities have needs in the lives of the people.

Recently, to further intensify on CIPs, the Management of the Service created the Department of Community Evaluation and Monitoring (CEM) under the Directorate of Special Duties. This Department is saddled with the responsibility to identify areas where the Service can embark on CIP to make meaningful impact as well as monitor where CIP projects need attention such as maintenance or repair.

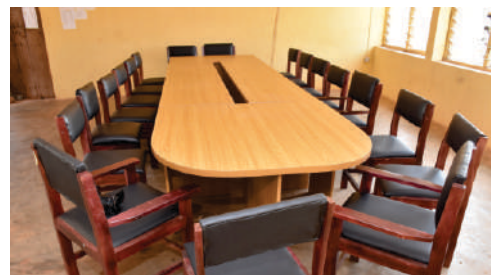

**D**r Muritala Awodun, Executive Chairman, KW-IRS stated that capacity development has been the watchword of the Service as well as a strategy to sustaining the quality of service delivery. He further stated that KW-IRS has since inception placed value on several capacity building programmes with the latest of such programme being the processing of International Organization for Standardization (ISO) certifications. He shared that the specific ISO certifications being processed are Quality Management System (QMS) and Business Continuity Management System (BCMS) certifications. He posited that

these certifications will place the Service on the pedestal of international standard for quality service and business continuity.

These statements were made while addressing the Press in the second quarter 2018 Media Parley event which held on 15 August 2018. Dr Awodun opined that holding of the media parley consistently is to ensure accountability to the people, and expressed satisfaction on the transparency and accountability displayed thus far.

The briefing, was centered on three major points which were revenue generation, sustainability of KW-IRS and the Community Impact Programme

(CIP) of the Service. He declared the revenue generated by the Service in the first seven months of 2018 as N11.66 Billion (Eleven Billion, Sixty-Six Million Naira) only.

In the area of sustainability, the Executive Chairman reiterated the activities of the service in the area of capacity building and establishment of international standard as the strategy to sustaining the value and integrity of the organization and its processes.

According to him, one of the methods KW-IRS has adopted to the give back to the society and impact positively in the lives of the residents of Kwara is the model tagged Community Impact Programme (CIP). This programme has helped the Service in the area of communal service and development interventions. The programme has touched several communities across the 3 senatorial districts in Kwara State and has helped in the mobilization of revenue in the State by fostering acceptance of the Service by the people.

Dr Awodun on enquiry from the Press mentioned some of the projects embarked on in the year so far which has included donation of transformers, distribution of school bags and books to pupils, drilling of bore holes, clearing of drainages and refuse dumps, and tax club quiz competition in

## Africa States'

### Progress Report

*Kwara State has been ranked second after Lagos in Nigeria in the latest Progress Report, titled 'The State of the States' released by Africa Report in its July/August, 2018 issue.*

The Africa Report is an international publication of reference dedicated to African affairs and is the guide used by decision-makers to anticipate economic and political changes in Africa. The publication is relied upon due to the expertise of an independent editorial team in its surveys, sector reports and country focus published in each issue.

According to information on the Africa Report, the survey of Nigeria's 36 states using indices with regards to fighting poverty, providing access to electricity, facilitating business and raising local revenue. In terms of access to electricity, Kwara was ranked third, sixth in terms of number of internet users, while tenth in the ease of doing business. The State also ranked tenth in the poverty index. The summation of all the indices led to Kwara State being ranked overall second in Nigeria.

The establishment of the Kwara State Internal Revenue Service (KW-IRS) by law in 2015 witnessed a change in the People, Process and Technology of revenue collection in the State.*

In terms of Internally Generated Revenue (IGR) per capita, Kwara ranked seventh out of the 36 states of the federation, and 10th on IGR collected. This rating is remarkable as Kwara in the past, rarely featured among states with high IGR. This feat was usually reserved for states like Lagos, Ogun, Rivers, Delta and Kano.

The revenue reform initiated by the Kwara State Executive Governor, Alhaji (Dr) Abdulfatah Ahmed has made it possible for Kwara to attain this remarkable feat. The establishment of the Kwara State Internal Revenue Service (KW-IRS) by law in 2015 witnessed a change in the People, Process and Technology of revenue collection in the State.

KWIRS in its two years of operation successfully restructured the State's revenue collection and administration by blocking revenue leakages and significantly shoring up the State's Internally Generated Revenue (IGR) without imposing new taxes. This consequently led to the exponential growth in revenue generation with growth since the inception of the Service.

In terms of change in IGR, according to the Joint Tax Board (JTB) and the National Bureau of Statistics (NBS), IGR figures for all states' financial year 2014-2016, Kwara moved from the least at -43% in 2014/2015 to second during its IGR reform in 2015/2016, bringing the overall change in IGR of the state to about 173%. From the JTB/NBS figures, no State in the country has recorded such feat. Since 2016, Kwara State annual change in IGR has hovered around 14-16%, while Lagos stood at around 7-8% according to JTB/NBS.

In 2016, KWIRS generated a total of N17.4b IGR for the State, which is higher than the N7.2b the State realized in 2015. In 2017, the agency generated a total of N19.6b, recording a 13.82 per cent growth from the 2016 figures.

This increase in IGR performance led State Government to launch the Kwara State Infrastructure Development Fund (IFK), in September 2016 as a sustainable platform designed to finance infrastructure without reliance on federal allocation.

IF-K is financed through an initial N5 billion seed fund and a N500 million –

N530million monthly contribution from the State's IGR. Since its establishment, the State government has released over N13billion to contractors handling various road projects across the State. Furthermore, through IFK, more than 144.5km of roads have been constructed by the State Government while some are ongoing and are at various levels of completion.

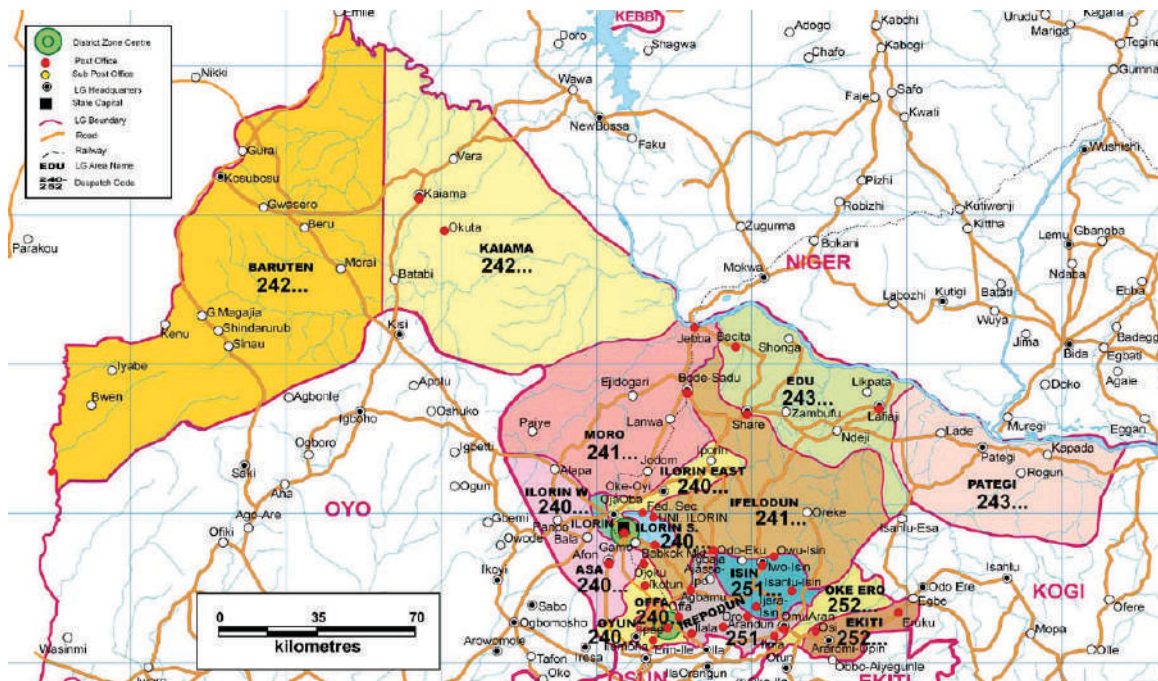
Some ongoing projects being funded under IF-K are the Geri-Alimi Diamond Underpass, Dualization of Sango-UIITH road, Ultra-modern Secretariat, Light-Up Kwara (LUK) Project, KWASU Campuses in Ekiti and Ilesha-Baruba, KWASU Post Graduate School in Ilorin, among others.

Given the above, it is therefore not a surprise that the Africa Report ranked Kwara State second among the 36 states of the federation using Internally Generated Revenue (IGR) as one of the indices.

Responding to the report, the Executive Chairman of KW-IRS, Dr Muritala Awodun commended the Africa Report for the thorough research work. While

addressing the Management Team of the Service, he admonished the members to keep steadfast in the vision to mobilise revenue for the strategic development of Kwara State. He opined that while many might view the report as an indication of attaining success, we (staff of KW-IRS) should view it as evidence that hard work does not go unnoticed and an encouragement to do more.

## President Buhari Signs Executive Order 8 on Offshore Money Laundering

President Muhammadu Buhari has signed Executive Order Eight, tagged Voluntary Offshore Assets Regularization Scheme (VOARS) to make money laundering and tax evasion difficult.

According to this order, Nigerian taxpayers that process offshore assets and income are expected to, within a period of 12 months, voluntarily declare those assets and pay 35% on the total value from such assets.

In a statement released by the President Buhari through his twitter handle stated that the Federal Government is stepping up the fight against corruption and targeting money laundering and tax evasion. The new Executive Order has taken effect from Monday 8 October, 2018.

“The office of the Attorney-General and Minister of Justice have been mandated to set up a VOARS in Switzerland for all categories of taxpayers who have defaulted in the declaration of offshore assets and payment of due taxes. Defaulting taxpayers who fail to take advantage of VOARS will, at the expiration of the scheme, be subjected to investigation and enforcement procedures. With the automatic exchange of information between Nigeria and foreign countries, there will be no hiding place for defaulters anymore” the statement read.

It is pertinent to note that under the Nigerian law, every citizen has the duty to declare his or her income and assets and pay accruable taxes but in Nigeria, the issues of tax evasion and avoidance are unsatisfied.

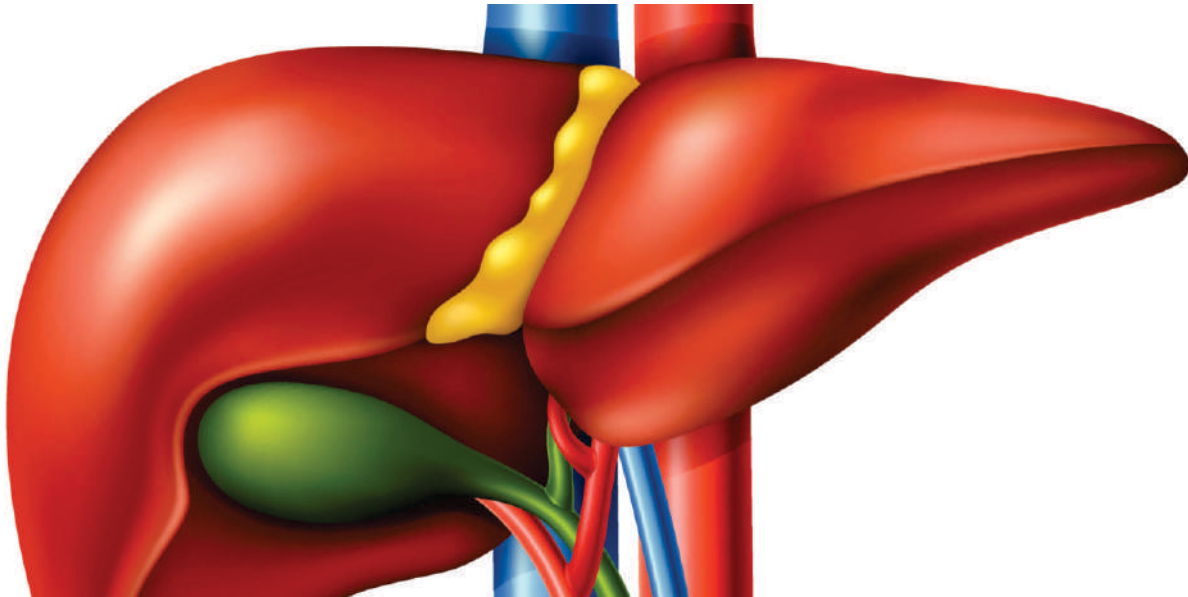

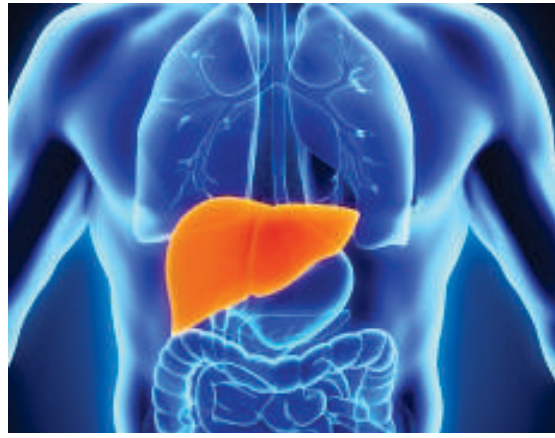

## TAX AVOIDANCE

Tax avoidance is the use of legal methods to modify an individual's financial situation to lower the amount of income tax owed. This is generally accomplished by claiming the permissible deductions and credits. This practice differs from tax evasion, which uses illegal methods, such as underreporting income to avoid paying taxes

For example, individuals who contribute to employer-sponsored retirement plans with pre-tax funds are engaging in tax avoidance because the amount of taxes paid on the funds when they are withdrawn in retirement is usually less than the amount the individual would owe. Furthermore, retirement plans allow taxpayers to defer paying taxes until a much later date, which allows their savings to grow at a faster rate.

**T**he increase of unemployment in Nigeria is alarming despite the efforts of the government to ensure its citizens are gainfully employed. ## DR AWODUN CHARGED YOUTHS TO BE INNOVATIVE

As part of activities marking 2018 International Youth Day, the Executive Chairman of Kwara State Internal Revenue Service (KW-IRS) Dr Muritala Awodun, has charged Nigerian youths to build an innovative capacity in approaching issues or challenges in their immediate environment beyond being creative. Dr Awodun made this statement during an event organized by the Kwara State Government tagged “Inspiring Innovative Thinking towards Self-Reliance, Economic Growth and Sustainable Development” held at the Kwara State Banquet Hall, Ilorin on Sunday, 12<sup>th</sup> August 2018.

of the Executive Governor, Dr Abdulfatah Ahmed who noticed the infrastructure gap of N255 billion and took a giant step by revamping the revenue collection process through signing into law the Kwara State Revenue Administration Law and the Kwara Public Private Partnership Bureau Law of 2015” Dr Awodun said.

He explained that the restructuring of the Revenue Service had provided over 700 direct jobs, 2,000 indirect jobs for revenue mobilization and 85 enterprises as consultants who also have engaged staff to carryout legitimate duties which was as a result of innovative thinking of the Executive Governor.

In his speech, the Executive Governor of Kwara State, Dr Abdulfatah Ahmed said under the Kwara Youth Empowerment Programme (KWAYEP), youths are deployed to various Ministries, Departments and Agencies and private agencies related to their academic background and given hands-on training over a specified period of time. The aim, he said was to provide youths with necessary skills to ensure they are able to compete with their counterparts all over the world.

While noting that youths make up about seventy per cent of the country's total population, Governor Ahmed opined that such population can be the tool for social and economic transformation with the right investment. He assured Kwarans that the State Government will continue to provide an enabling environment for youths to contribute to the socio-economic development of State.

The Senior Special Assistant to the Governor on Youth Empowerment, Alhaji Saka Babatunde advised youths to look beyond engaging in solely public services, but to be creative and innovative so as to be self-reliant. He commended Governor Abdulfatah Ahmed for making youth development a priority.

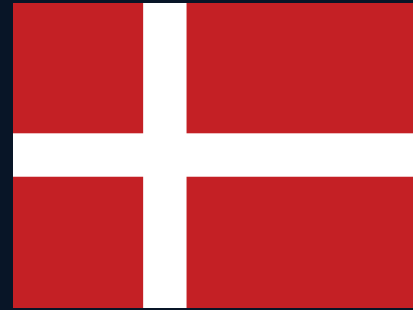
## Denmark Invests Further In Tax Administration

Danish Minister of Taxation Karsten Lauritzen has announced that the Government has allocated an additional DKK2.2bn (USD342m) for the modernization of the tax authority's administrative systems in an attempt to strengthen tax collection.

Approximately DKK1.5bn of the additional funds will be used to help collect tax debts and to improve the valuation of properties for tax purposes, with DKK600m to be spent on updating the tax authority's IT infrastructures since approximately 200 IT systems, some of which have their origins in the 1960s and 70s, explained Lauritzen.

The Government has allocated a total of DKK13bn to the tax authority modernization program since 2017, Lauritzen added.

A comprehensive administrative overhaul of Denmark's tax authority was instituted on July 1, 2018, with a series of new specialized boards becoming operational. Under the changes, the tax authority has been split into seven separate entities, each of which has a core area of competency.



## Croatia To Delay VAT Rate Cut Until 2020

The Croatian Government has announced that it will delay a planned one-percent value-added tax cut until 2020 but will cut VAT on some basic commodities from the beginning of next year.

The 25 percent VAT rate, which was proposed to be reduced to 24 percent from January 1, 2019, will instead be cut by one percent from January 1, 2020. The 13 percent reduced rate will newly apply to fresh meat, fish, fruit, diapers, and vegetables.

Croatia applies three rates of VAT: 25 percent, the second-highest in the EU after Hungary, a 13 percent reduced rate, and a five percent rate. The 13 percent rate applies to certain printed media, admission to certain cultural shows and events, agricultural inputs, hotel accommodation, some funeral services, electricity supplies, certain waste management services, edible oils and fats, baby food, processed cereal-based foods for infants and children, and food for animals.

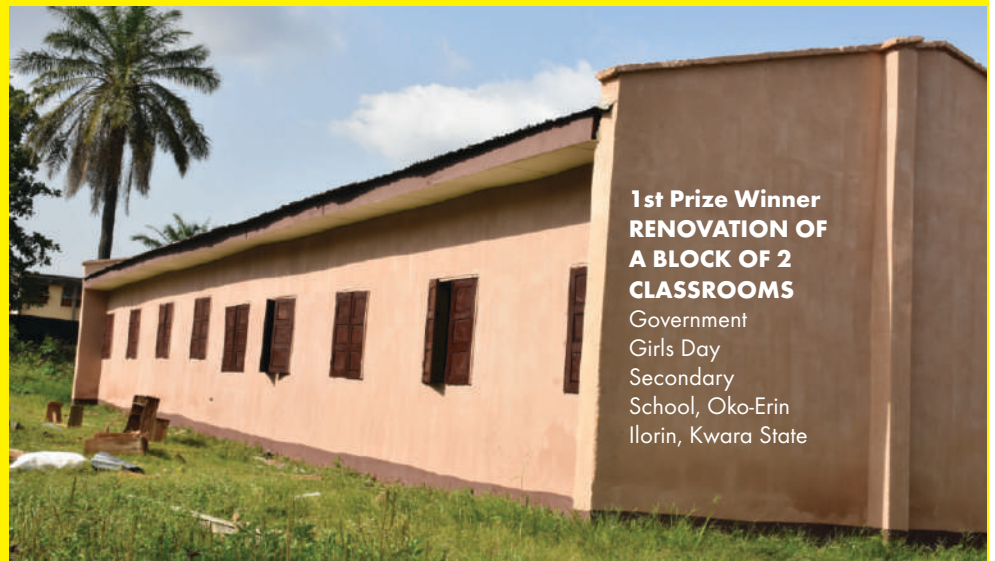

# KW-IRS & KWARA STATE HOSPITALS MANAGEMENT BUREAU VISIT HOSPITAL FACILITIES IN KWARA NORTH

In a bid to make Kwara State Secondary and Tertiary Health Care Delivery System effective to serve the residents of the State better, the Kwara State Internal Revenue Service (KW-IRS) Director of Ministries, Departments and Agencies (MDAs) Mr Lekan Rotimi and the Director General of Kwara State Hospital Management Bureau, Dr. Saad Oladimeji Issa visited hospitals in Kwara North Senatorial District for critical need assessment, on-the-spot check, and collection monitoring on 13<sup>th</sup> of September, 2018.

The DG of Kwara State Hospital Management Bureau in his statement said the visit was necessary so as to assess the level of operation of the hospitals, their needs and how the State Government can improve the health sector of the State. He expressed believe that the challenges of dilapidated buildings, poor equipment, inadequate medical personnel and security will soon be a thing of the past. Dr Saad Oladimeji encouraged the workers to be diligent and professional in discharging their duties.

The KW-IRS Director of MDAs stated that the revenue generated from Kwara State hospitals was below expectations and this was of concern for the Revenue Service. For increased patronage, he said the hospitals needed to improve on their service.

He also noted that it was impracticable for government to keep funding hospitals that can't break-even or operate at the optimum level and warned that no hospital should charge an extra fee apart from the price list approved by the Hospital Management Bureau.

# The Tax System & Vision 20:2020 - *Will Nigeria arrive early?*

*With the renewed commitment by the Federal Government to diversify the economy by growing the non-oil tax revenue in order to develop stable and sustainable revenue source to finance developmental projects, the tax system must be re-wired to be more flexible and adaptive to facilitate these aspirations*

**N**igeria's archives are littered with series of programmes geared towards social, political and economic transformation of the nation. These programmes have either been poorly implemented, neglected or outrightly abandoned. The magic word for such programmes in the last 15 years is Vision. Thus, Nigeria had Vision 2000, Vision 2010 and now the latest, Vision 20:2020. The latter is the vision that expects Nigeria to be one of the 20 largest economies in the world, able to consolidate its leadership role in Africa and establish itself as a significant player in the global economic and political arena.

Some key parameters of Vision 20:2020 as set by the Federal Government are as follows:

# TAX MATTERS



- **Polity:** a peaceful, harmonious and a stable democracy Macro-economy: a sound, stable, and globally competitive economy with a GDP of not less than \$900 billion and a per capita income of not less than \$4,000
  - **Education:** modern and vibrant education system which provides opportunity to maximise potential and develop adequate and competent manpower
  - **Agriculture:** a modern technologically enabled agricultural sector that fully exploits the vast agricultural resources of the country, ensures national food security and contributes to foreign exchange earnings
  - **Manufacturing:** a vibrant globally competitive manufacturing sector that contributes significantly to GDP with a manufacturing value added of not less than 40%
  - **Infrastructure:** adequate infrastructure services that support the full mobilisation of all economic sectors
  - **Health:** a health sector that expects and sustains a life expectancy of not less than 70 years and reduces to the barest minimum the burden of infectious and other debilitating diseases
- Delivering on these parameters demands significant financial commitment /investment by the Government. Despite the enormous human and natural resources that Nigeria possesses, the frustration at the parlous state of infrastructure and social service delivery systems is manifest in the almost perennial lamentation and agony by young and old, rich and poor, "nothing works in this Nigeria". And the reason for the apparent failure of governance is the elusive and unknown but ubiquitous scapegoat called the "Nigerian factor".
- Many citizens wonder whether there is any justification for the continuing deduction of taxes on their incomes or payment of other levies/fees when the expected social benefits to which the revenue were to be applied, have remained non-existent or grossly inadequate. In contrast, citizens are riddled with stories of bold-faced corruption and misappropriation of government funds.
- Nevertheless, the financial challenge facing government at all levels of the Federation is a reality since the crash in crude oil price and its sustained slump till date. Taxes (in whatever shade or hue) remain the only significant best alternative source of revenue to the government. As a result, socially responsible



individual and corporate citizens must not hamstring government by refusing or neglecting or wilfully defaulting to pay due taxes on their income and transactions timeously.

Accordingly, how the tax system is positioned to perform from this year till 2019 will be critical to whether the current administration will be able to answer satisfactorily the following three development questions in relation to Nigeria:

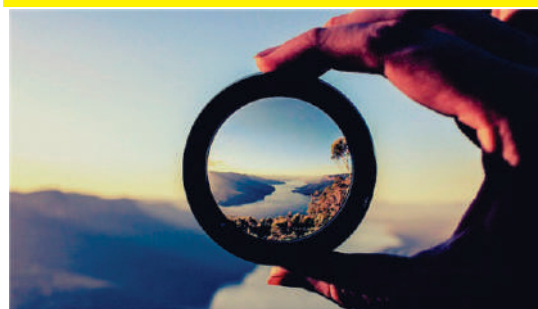
- What has happened to unemployment?
- What has happened to inequality?
- What has happened to poverty?

The challenge for all revenue generating /recovery agencies of government therefore remains how to:

- Increasingly drive operational efficiency and eliminate waste
- Increasingly simplify the compliance process and eliminate any extant hassle factors/layers of bureaucracy precluding ease of remittance of taxes
- Expand the tax net to include perennial tax defaulters and fringe taxpayers or any other catchment
- Resolve the twin burdens of multiple taxation and double taxation on individual and corporate taxpayers howsoever they manifest in the system or framework
- Expand access to and usage of electronic platforms such as ITAS (for FIRS) and ASYCUDA (for NCS) and any other electronic platform in use by relevant government agencies.

For instance, in the case of ITAS by FIRS, one of the objectives is to automate and simplify tax compliance process through online submission of tax returns, processing of tax clearance certificates, validation of tax identification numbers, storage of taxpayers information etc. While taxpayers eagerly await the full implementation of ITAS, taxpayers expect that the platform would be upgraded to enhance or enable an automatic electronic credit system for withholding tax to eliminate the present frustration encountered in relation to credits

entitlement without supporting certificates and resultant delay in utilisation and direct cashflow impact.

As Dick Armeý said, “If we are to create tomorrow's jobs, we cannot remain frozen in time in yesterday's tax system”.

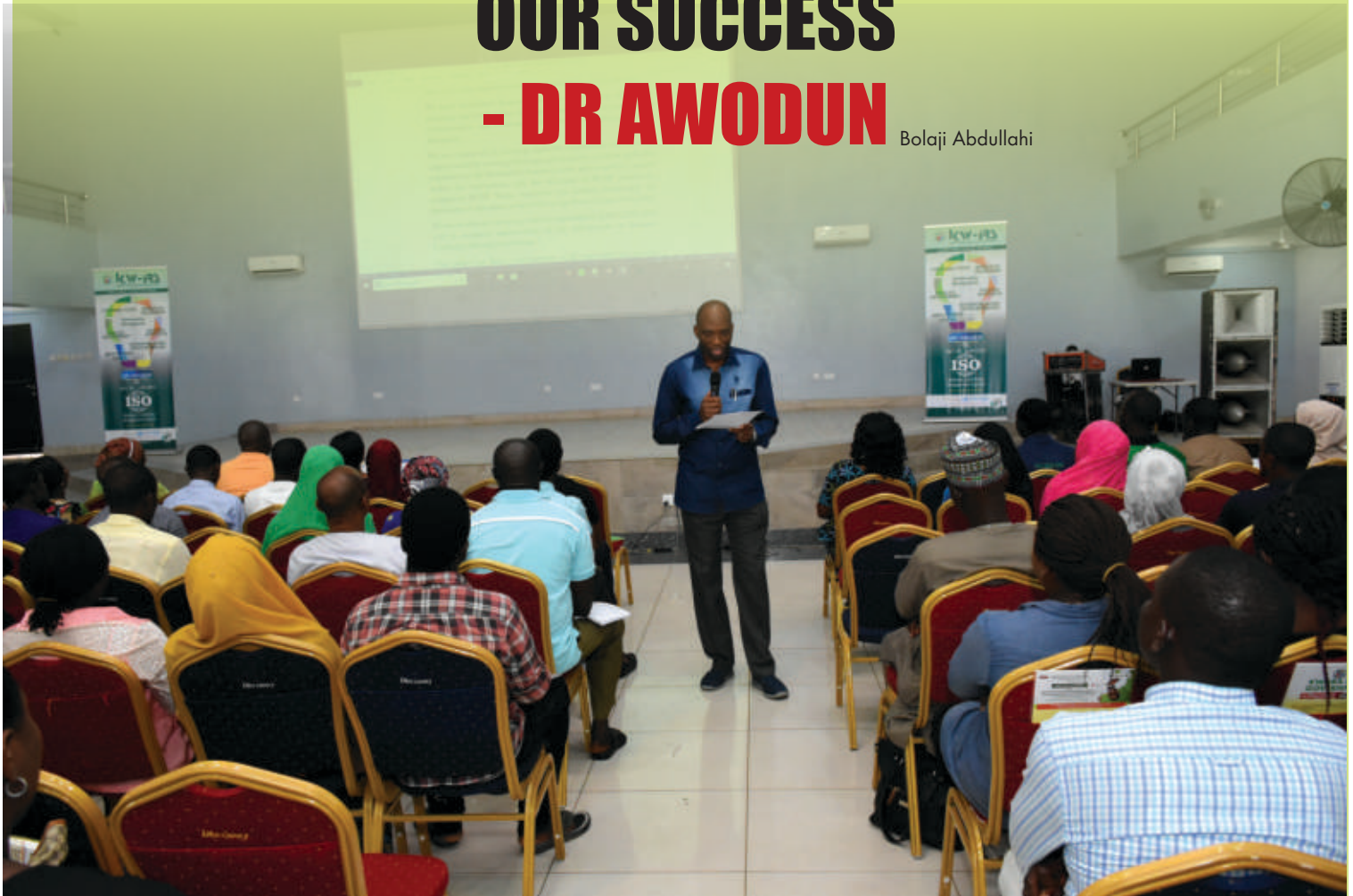
