### KW-IRS ORGANIZES TAX EDUCATION WORKSHOP FOR EMPLOYERS OF LABOUR IN KWARA STATE





In line with its commitment to ensuring continuous taxpayer sensitization, the Kwara State Internal Revenue Service (KW-IRS) organized a Tax Education and Awareness Workshop for employers of labour in the State on Wednesday, 15th January, 2025, at the Kwara State Banquet Hall, Ilorin.

The workshop themed "Enhancing Tax Compliance through Stakeholder Sensitization and Engagement," served as a vital platform for bringing together es, and adhere to payment deadlines.

designated employers, offering essential insights on filing of annual tax returns and streamlining tax payment processes.

Delivering her keynote address at the workshop, the Executive Chairman, KW-IRS, Shade Omoniyi, emphasized the critical role of taxation in driving economic development; describing it as the foundation for financing essential public services such as infrastructure, education, and healthcare.

While acknowledging persistent challenges associated with tax compliance in the State, the KW-IRS boss outlined the need for collaborative strategies and active stakeholder engagement to foster a transparent and efficient tax system. She highlighted issues bordering on the KW-IRS harmonized bill, implications of non-compliance, and the 2024 Withholding Tax Regulations alongside the proposed tax reforms in Nigeria, and urged participants to embrace voluntary compliance, register unlisted businesses, file tax returns promptly, declare all income source.

The workshop featured five paper presentations from staff of KW-IRS on topics relating to tax compliance. In his presentation, the Director, MDAs, Omotayo

Ayinla, highlighted the importance of the harmonized bill which consolidates the multiple tax types collectible by the Service into a single document, ensuring clarity, and simplifying the taxation process for both taxpayers and the tax authority.

Muhammed Audu emphasized that filing Annual Returns is mandatory, and non-remittance of taxes is punishable under relevant laws. He further explained that non-compliance attracts serious consequences, including legal penalties, financial losses, reputational damage, and potential operational disruptions.



During his presentation, Mohammed Kabiru Rufai provided a practical guide on filing annual returns for both corporate organizations and individuals, using the KW-IRS Self Service Portal. Participants were allowed to file their annual returns following the step-by-step guide provided, and prizes were won by those who were able to submit their returns on the spot. Rufai underscored the importance of submitting employees' nominal roll and annual tax returns by employers to ensure accurate reconciliation of remittances for each organization.

Kuburat Yinusa made an extensive presentation on payment options and platforms provided by the Service. She raised awareness on the seamlessness of tax payments through the Self-Service Portal, highlighting it as a key component of the State's automation goals.



Abdullahi Gegele, in his presentation on Withholding Tax Regulations and the Proposed Tax Reforms, highlighted key aspects of the new tax reforms, including streamlined processes, improved taxpayer database, and stricter compliance requirements. He stated that these reforms aim to promote efficiency, transparency, and convenience for both individuals and organizations.

The workshop addressed frequently asked questions about the harmonized bill, annual returns filing, and the proposed tax reforms.

Wrapping up the event, the KW-IRS Director, Income Tax, Mohammed Usman, expressed appreciation to participants for their time and support in ensuring tax compliance and contributing to the growth of Internally Generated Revenue (IGR) in the State.

The workshop had in attendance management and staff of KW-IRS and representatives from various organizations across the State.

## KW-IRS CRACKS DOWN ON TAX DEFAULTERS IN ILORIN


In pursuance of its mandate to optimize revenue mobilization for the development of the State, the Kwara State Internal Revenue Service (KW-IRS) embarked on massive enforcement of tax defaulters in Ilorin the State capital on Monday, 20th January, 2025. The enforcement exercise became necessary after all measures to ensure that the affected businesses performed their civic responsibility proved abortive.

The exercise, which took place in collaboration with relevant security agencies in the State, led to the sealing of some business premises along Taiwo Road, Oja Iya, Pipeline Road, Tanke, Unity, Ahmadu Bello Way, and Yoruba Road in Ilorin, resulting in several taxpayers immediately paying their outstanding tax liabilities to ensure business continuity, while some other businesses remained sealed.

KW-IRS implores taxpayers to pay all tax liabilities and file needed tax returns promptly to avoid paying penalties and fines as the enforcement of defaulters will continue across all sectors of the State.

The Service has also provided a user-friendly online Self-Service Portal (SSP) and other various payment channels where all tax-related activities can be carried out seamlessly.





## KW-IRS HOLDS STRATEGIC MANAGEMENT RETREAT TO CONSOLIDATE REVENUE GROWTH IN 2025



he Kwara State Internal Revenue Service (KW-IRS), in fulfilling its mandate of mobilizing revenue for the strategic development of Kwara state, held a two-day strategic management retreat to evaluate 2024 achievements and outline actionable blueprints for enhanced Internally Generated Revenue (IGR) in 2025.

The retreat, which took place on the 24th and 25th of January, 2025, at Bovina View Hotel, Ilorin, brought together the Executive Chairman, top management team, Heads of Departments, and selected staff of the Service.

Delivering her opening address, the Executive Chairman, Shade Omoniyi, expressed gratitude for the collective efforts in achieving revenue milestones in 2024. She emphasized the need to sustain progress through alignment with Nigeria's tax reforms, focusing on their implications for the State's IGR and mapping out strategies to bridge the gaps that may arise from the reforms or fully consolidating the new opportunities they will bring. Omoniyi encouraged active participation in discussions to drive innovative solutions and outlined four key Tax Bills underpinning the reforms namely; the Nigeria Tax Bill, the Nigeria Tax Administration Bill, the Nigeria Revenue Service Establishment Bill, and the Joint Revenue Board Establishment Bill. She therefore called for unity,

innovation, and commitment to setting a new benchmark in tax administration for 2025 which has been tagged "Our Year of Consolidation" by the Service, while expressing optimism for the year and reaffirming the Service's dedication to its mission.

The retreat featured a keynote presentation by Adetola Ogbebor, Lead Coach at MaxLife Coaching Company, themed "Leading to Make a Difference." Her session delved into visionary leadership, bridging leadership gaps, leadership styles, and achieving effective leadership using the PPT Model which implies Personal Effectiveness, People Leadership and Task Leadership. Participants were inspired to adopt strategic thinking, explore leadership myths, and refine their leadership qualities.

Strategic presentations from KW-IRS Directorates and Departments provided insights into objectives and initiatives for 2025. The sessions encouraged open deliberations, resulting in the adoption of innovative technologies, exploration of untapped revenue potentials, and implementation of strategies to improve revenue collection across the State. Participants also engaged in morning aerobic sessions to foster camaraderie and overall wellbeing.

In her closing remarks, the Executive Chairman reflected on the retreat's success, describing it as one of the most collaborative and productive sessions in recent times. She expressed confidence in the outcomes of the retreat and wished all participants success in driving the Service's objectives for the year.

#### KW-IRS and Ministry of Business, Innovation & Technology Inspect Gbugbu Market, Engage Emir of Lafiagi on Economic Growth



As part of the Kwara State Government's commitment to fostering economic development under the leadership of His Excellency, Governor AbdulRahman AbdulRazaq, the Kwara State Internal Revenue Service (KW-IRS), in collaboration with the Ministry of Business, Innovation, and Technology, conducted an inspection of Gbugbu Market in Edu Local Government on Tuesday, 4th February, 2025. During the inspection, KW-IRS Executive Chairman, Shade Omoniyi, emphasized the importance of streamlining revenue collection within the market and fostering better coordination between local and state government authorities to enhance effective market management.

She expressed concern over the underutilization of the market and called for strategic measures to maximize its potential. In response, the Bursars of the institutions aired some of their challenges and committed to exploring innovative solutions to increase revenue and ensure timely payment of outstanding debts.

Omoniyi, clarified that although the Service since the commencement of the current administration frowns at all manners of wasteful spending and unproductive activities, however, KW-IRS remains committed to providing a friendly community for businesses to thrive.

The sensitization program featured a series of paper presentations from KW-IRS tax executives, focusing on encouraging ethical working

relationship between the revenue agency and the creative industry in the State; the need for proper record-keeping of business transactions, prompt filing of annual tax returns, creation of a designated business account, among other discussions.

The presentations also examined various types of taxes applicable to the sector, and the principles of taxation, while also clarifying some misconceptions that have been associated with the KW-IRS brand over the years.

The sensitization program also featured a questions and answers session, where participants sought clarity on tax-related issues in relation to their businesses.

The KW-IRS Director, Income Tax, Mohammed Usman, while delivering his closing speech expressed appreciation to the participants for attending the session and their continuous contributions to the economic viability of the State. He assured them that the Service will maintain fruitful relationship with business owners in the State irrespective of their categories.

The event had in attendance members of the KW-IRS top management team, some Heads of Departments, and selected department representatives from the Service.

Omoniyi therefore enjoined the tax consultants to focus on enhancing tax compliance by taxpayers rather than being engaged to reduce their tax liabilities.

Also lending his voice to the discussion, the Director, Income Tax, Mohammed Usman assured the Forum of a harmonious working relationship, since the tax consultants will not work in contrast to what the Service stands for.

The Head, Tax Assessment, Abdullahi Gegele shed light on the treatment of objections raised by tax consultants on behalf of taxpayers, explaining that the Service has put in place an internal control mechanism that ensures that things are done the right way. The Head, Tax Audit, Mohammed Kabiru, also highlighted the importance of accurate filing of annual tax returns to ensure that the Service has the necessary information to work with.

He also charged the tax consultants to advise and educate taxpayers on what is expected of them by the law.

Also in attendance were the Head, Corporate Affairs, Funmilola Oguntunbi, and other staff of KW-IRS.
